

## Our Privacy Policy

Breaking the Silence respects and takes seriously each of our site's users right to privacy. This Privacy Policy explains how and what types of user information we collect, store and use.

Breaking the Silence (hereinafter: 'the organization') collects and uses **unidentifiable** information on any user, as they browse the site, for operative and statistical purposes.

Personally identifiable and unidentifiable user information, is collected as users browse the site. It may be stored in the organization's databases, and used, among other things, for managing and improving the user experience, and/or for research, and statistics.

The organization **will not** make commercial use of collected data, and will not pass on personal details to any third party without consent, unless required to do so by law.

We may use cookies on our site to ensure the site's performance and maintenance, including collecting statistical data regarding use of the site, verifying details, data security, and adapting the site to your personal preferences, including personalized advertisements while browsing other sites.

Cookies are file text created by your browser in response to the site's computers. Cookies can include varied information as to pages you've visited, time spent on the site, how you reached the site, information that you wish to see upon landing on the site, and more. Cookies do not include personally identifiable information.

Cookies are meant to present ads for products or services based on the various sites you have visited, and services you have used, on the internet (a method called 'retargeting').

We also use cookies from third parties, including Google Analytics, Google's advertising services and social media, such as Facebook. The data collected is used by Google to prepare activity reports regarding the site and the manner in which it is used. This can be prevented by [downloading and installing](#) an extension to your browser.
